## Course Description

This course guides students through the exploration of the functions of sound and music, the evolutionary origin of theatre, and how a sound designer/composer can take advantage of this knowledge in their work. During each class meeting, students will present their projects followed by a discussion.

## Prerequisite Knowledge and Skills

This course assumes no prior knowledge or skills in sound design. Ability to use a DAW (Digital Audio Workstation) or QLab may be helpful, but is not required.

## Course Goals and/or Objectives

After you complete this course, you will:

- Be able to articulate your aesthetic regarding the art of sound.
- Be able to identify the elements of color, mass, time, space, and line in sound music.
- Be able to understand better the relationship between music and the brain.
- Have participated in a number of exercises in composing sound scores.
