Contemporary issues and problems in music education. Investigating and planning research relevant to selected problems.

Course Overview

The purpose of this seminar is to further develop the skills required to conduct, write-up, and present research using quantitative, qualitative, and mixed methods approaches through the design and implementation of a research study. Throughout this seminar, students will engage in a writing process that will encourage them to become productive scholarly writers. They will focus on writing for publication and will develop and give a conference-style presentation based on their research. Additionally, techniques for facilitating class discussions will be explored.

Course Goals and Objectives

Through full participation in the course, students will...

- 1. Understand and apply quantitative, qualitative, and mixed method research techniques.
- 2. Design and carry out a research study utilizing an appropriate method of inquiry.
- 3. Develop and strengthen writing skills, habits, etc.
- 4. Develop and strengthen presentation skills in a conference-style setting.
- 5. Lead and engage in class discussions.
