Course Description:

Synthesis and exploration of techniques for auditioning; information and advice about the business of acting-trade unions, contracts, agents, etc.

AUDITION (PROFESSIONAL ACTOR) WORKSHOP: Designed for students with serious intent on pursuing professional careers in the field, the course explores the primary facets of the business of being an actor in the context of a major entertainment market including (but not limited to) marketing and promotion, representation, auditioning and the development of an effective practical skill set to procure and secure employment and sustain a life-long career in the industry.

OBJECTIVES/GOALS:

- To acquire a working knowledge of the elements of the audition process as they apply to general auditions, prepared scenes, cold readings, improvisation and interviews as a means to strengthen performance within the audition event
- To develop a vocabulary and an extensive working knowledge of concepts with which to develop a repeatable, effective audition process
- To demonstrate an ability to frame class work within the context of the professional workplace
- To exhibit a bravery in exploration, rehearsal and performance
- To demonstrate the capacity to think critically and articulately about the audition process.
- To develop ways for the actor to project the best representation of himself in an audition scenario
- To demonstrate a more confident understanding of the primary facets of the business of pursuing and securing employment as an actor in the context of a major market

EXPECTATIONS REGARDING BEHAVIOR/DEMEANOR: One goes to a good school to get a good education and, in turn, to get a leg up in her profession. The professional workplace demands disciplined work and behavior. Otherwise, you get fired and create a very bad reputation for yourself. Bad reputations get around. A similar work ethic is required of you in this class, as an advanced-level college student, a responsible citizen and future professional. Assignments will be completed in a timely, thorough fashion. They will meet a level of sophistication fitting for advanced students of the theatre. Also: Attendance is mandatory. (See Attendance Policy.) To learn to act, you must act. To act, you must be here. Your learning comes in the shared experience. Your participation has as much to do with others' growth as your own. Your absence is costly to everyone. The professional theatre does not make allowances for illness. Actors do not have the luxury of getting sick. Exercise. Eat healthfully. Drink lots of water. Don't smoke. Your body and your breath are your greatest tools as an actor. Protect them. Please note: Attendance is not the same as participation. You are expected to be not only physically present, but mentally. You will be expected to demonstrate your understanding of class concepts by the comments and criticisms you make. Speak thoughtfully and often.

ATTENDANCE POLICY: In an attempt to create a disciplined environment that simulates the demands of the actor's work place, I will enforce an attendance policy that allows little room for you to exert any personal control over the business of being an actor. The callback, the shoot, and the evening's performance do not wait for your good health or your good night's sleep. Sometimes you must work tired or work sick. Sometimes you fake it. Sometimes it is during these times that you do your best work (being too tired to put energy into all your old bad habits.)

***Absence due to illness must be documented. Other activity resulting in absence must be documented in advance. Excused absences will be considered (see UF Undergrad Catalog Attendance Policies) and includes the following:

1) Documented medical reason; 2) Documented university obligation that has been submitted in advance; 3) Documented family emergency; 4) Religious Holiday.

-You are allowed two unexcused absences. Each additional unexcused absence results in a reduction of one half a letter grade.

***In the same way, tardiness will also be penalized. It has no place in rehearsal, at auditions, at your early morning call on set for a shoot or at half-hour in the theatre, and it has no place in the classroom.

-You are allowed two tardy arrivals. Each additional tardy results in an unexcused absence.

Simply put: Do the math, show up for class, stay healthy, and develop a discipline that will keep you working.

POLICIES REGARDING MAKE-UP WORK AND LATE WORK:

Excused absences do not make one exempt from class obligations. Work must be made up in a timely fashion, at the discretion of the instructor, typically in the week follow the student's return to class. Unexcused late work will be penalized at the discretion of the instructor, with penalties increasing relative to lateness.
