Course description:

This lecture course addresses key artistic practices and movements from the mid-1960s to the 1990s.

- Monday session will include time for questions and group discussion.

COURSE POLICIES:

<u>Class Attendance</u>. Attendance will be taken. Unexcused absences will adversely affect the Attendance and Participation portion of your grade as well as your performance on Assignments and Exams.
