Course Description

Elements of classroom string instrument instruction and technique (violin, viola, cello, and double bass).

Objectives

To prepare students to play and teach the violin, viola, cello, and bass at various educational levels with emphasis on classroom situations.

To further develop knowledge and understanding of:

- 1. Playing technique and skills
- 2. Care, maintenance, repair, rental and purchase of instruments, bows, and accessories.
- 3. String notation, articulation, technique, and terms.
- 4. Current trends in string teaching.
- 5. Pedagogical literature and resources, repertoire lists, and audiovisual aids related to string instruction.

Materials

Required text: D. Hamman and R. Gillespie, Strategies for Teaching Strings, Oxford Pub., 3rd. Ed., 2012; notebook; folder or other system to collect handouts and other materials

Class Activities

Each student will study at least one string instrument. Much of the class time will be spent learning to play the instruments, as they require a great deal of coordinated small motor movement. Students will choose or be assigned an instrument different from that studied in String Skills 1. Quizzes which cover the required readings will be administered as necessary, sometimes without warning. Classes will also include student presentations and demonstrations.

Course Schedule

As string skills1 was taught by a different instructor, the weekly content of the course will be determined after student meetings during the first week of classes to establish acquired knowledge and student needs. (N.B. Content may be changed at any time as mandated by student needs)

Grading

Attendance (40%)

Ouizzes (20%)

Quizzes will pertain to reading assignments as well as class discussion.

Exams (20%)

- 1. Performance exams consisting of prepared material, scales, and sight-reading.
- 2. Class presentation/teaching.

Other Activities (20%)

1. Concert Review - turn in a one page (singe space; 400-600 words) report of a concert featuring string instruments. Relate you discussion to aspects of string playing we have covered in class.

- 2. Music Journal Article Review turn in a one page (single space; 400-600 words) review of a music journal article (The instrumentalist, American String Teacher, etc.) relating to a specific aspect of string playing.
- 3. Class Notebook present an organized notebook at the written final that contains all class notes, handouts, assignments, and other materials related to the course. This notebook will serve as a resource guide when you enter the workforce.

Grades are determined by dividing the points earned by the total number of points possible (weighted by category). Grades will be based on current UF grading policies that can be found at: https://catalog.ufl.edu/ugrad/current/regulations/info/grades.aspx.

Attendance Policy
