<u>Course Description:</u> This course is designed to give graduate students an introduction to selected operatic genres and related works from the early seventeenth through the twenty-first centuries. Students will explore dramatic and musical conventions, performance practice, reception history, and the role of performers in the creation of works. We will survey some of the central literature and consider the changing relationship throughout opera's history among drama, music, and spectacle, and the position, function, and meaning of opera in society at different times and places. Class meetings will consist of presentations of material, listening, score study, oral and written reports, and discussions. Requirements include two exams and a research paper.

Policies and Course Information:

Emphasis will be placed on discussion of readings and scores (book chapters, articles, and other materials). It is essential that students read all assigned material before each class and come prepared with questions and/or comments about them. Class meetings will consist of a combination of discussion, oral and written reports, score study, and presentation of material. Comments on paper drafts or other parts of the paper assignment must be incorporated to the next. Late submissions of any assignments will receive a reduction in grade to be assigned at instructor's discretion. Any changes to the syllabus, should they occur, will be announced in class and timely notice will be given. Final version of papers will be submitted to the instructor in hard copy and through Turnitin.com (through E-Learning) as well.

ATTENDANCE POLICY: Attendance will be taken at each class session. Students are expected to be on time, present, prepared, and actively engaged for every session for the entire period. Excessive absences, tardiness, and lack of preparation will be noted and will affect the final grade. Specific criteria for make-up assignments to be distributed in class.

Cheating and/or plagiarism on exams will result in disciplinary action. A make-up for the midterm will only be administered in the case of an excused absence and must be completed within one calendar week of the scheduled exam date. The final exam is take-home and no late submissions will be accepted.
