Course Description (Catalogue):

Student actors study, experiment, and produce in a laboratory emphasizing specialized skills and methods.

Purpose/Objective:

Practical experience in repertory theatre with direct skills application in rehearsal and performance. By using summer production work as a learning tool, the student gains an understanding of the actor's contributions and responsibilities in production through practical application of knowledge, including an effective approach to and execution of an acting process. The student's working methods, skills, progress and professional conduct in completing an assigned role in production will be assessed and evaluated.

Expected Outcome:

MFA Students will demonstrate artistry and professional behavior in rehearsal and production.

Attendance:

Students are expected at all rehearsals and performances.

Tardiness and unprofessional behavior will affect the final grade.

Deadlines:

Students are expected to meet all deadlines including off-book dates.

Dress:

Students are expected to dress appropriately for rehearsals in a way that allows actors to rehearse and explore specific character and scene work. It is expected that students will bring the necessary rehearsal clothes to rehearsal, including appropriate footwear, trousers/skirts, vests/jackets, and knee/elbow pads as necessary. In rare and individual circumstances, the costume shop will supply specialty pieces.

Master Classes and Panels

MFA Acting Company, Summer, typically includes a number of professional guest artists in commercial theatre practice and producing. Optional master classes and/or roundtable panels may be offered for

students enrolled in MFA Acting Company. While attendance is not mandatory, all students are encouraged to attend. Flyers promoting such classes will be posted on callboards.

Grading/Assessment:

Grading evaluation is based upon the their artistic/scholarly work, communication/decorum/attitude, professional behavior, and overall participation in projects. Each rehearsal or production team may establish ground rules for expected demeanor and work performance. Failure to arrive on time for performances or rehearsals, as well as unexcused absences, will significantly impact the final grade.

While the Director of the School is the Instructor of Record, the invited guests working on productions will be consulted regarding evaluation (see attached sample rubric). Typically, the director of the production, playwright, composer, and/or the Production Manager are the relevant individuals consulted in student assessment.

MFA Actors will be assessed in the following areas:

Artistic/Scholarly

- Synthesis of connections between voice, movement, and intellect/analysis in character creation
- Integration of scholarly/dramaturgical research with creative imagination in character interpretation
- Thoroughness and attention to detail

Communication/Decorum/Attitude

- Working relationship with Director
- Working relationship with Stage Manager and Stage Management Team
- Positive collaboration with ensemble/cast
- Pleasant and cooperative attitude
- Ability to work calmly and effectively under pressure

Professional Behavior

- Participated in an effective and appropriate communication process using proper channels of communication
- Punctuality and attendance
- Proper Preparation (met off-book deadlines, prepared for scene work, etc.)
- Ability to maintain a consistent performance
- Adherence to safety procedures
- Appropriate attire for rehearsals
