### Course Description/Purpose:

TPA 4931, Advanced Stage Management Seminar, is a repeatable course for undergraduate School of Theatre and Dance students that is part seminar and advanced topics. The seminar portion serves as a forum for peer sharing and problem solving on current production assignments. Rotating topics are specific to the stage management profession and industry trends.

## **Course Objectives and Student Outcomes:**

#### **Seminar Portion:**

- To discuss and reflect on School of Theatre and Dance production assignments through weekly class discussions.
- By the end of this course students will:
  - o Continue to develop their own collaborative style.
  - O Develop skills as a discussion facilitator.
  - Have the ability to generate meaningful questions to promote productive dialogue and peer exchange.
  - O Advance their own and their peers' level of problem solving from the perspective of a stage manager and assistant stage manager.

### **Advanced Topic Portion:**

- To acquire an introductory understanding of Actors' Equity Association (AEA) and the AEA LORT Rulebook. The concentration of this topic is on the practical use and application of AEA resources and the rulebook from the perspective of an AEA stage manager.
- Explore the relationship between AEA stage managers, the AEA union, producers, directors, AEA actors, and non-AEA actors.
- By the end of this course students will:
  - o Have the ability to navigate AEA resources including actorsequity.org, resources in the AEA document library, and the AEA LORT Rulebook.
  - o Achieve clarity in communicating AEA information with collaborators.
  - O Develop a creative and interactive presentation focusing on AEA rules and information.

# Required Text:

All reading materials will be provided through <u>actorsequity.org</u> and the course E-Learning site

### **Course Requirements:**

- Full participation in all class discussions, activities, and assignments.
- Complete all assignments on time.
- Be prepared to present and discuss assignments each week.
- Participate in production assignment reflection and current event discussions with an honest and respectful attitude.
- Everyone in class should be open and supportive to viewpoints of fellow classmates and accepting of peer feedback.
- Exercise confidentiality as production assignment challenges and opportunities are explored.

### **Course Assignments:**

## • SoTD Production Assignment Reflection/Discussion

(Role as facilitator and discussion participant graded)

- O Students are assigned to facilitate discussions based on their current SoTD Production Assignments. The goal of the discussions is to explore challenges, best practices, and foster solution-oriented dialogue with peers. Productions in rehearsal and performance will be prioritized for longer discussion. Students may provide additional information to support discussion from other sources. Examples may include a recently published article, media reference, etc.
- o In preparation for the weekly discussions, student facilitators will post topics and related questions for the class to consider to the course E-Learning site (no later than the Thursday prior to each class discussion at 5pm).
- O Student facilitators are defined as stage manager or assistant stage manager assigned to a SoTD production. A schedule of weekly facilitators will be posted on the E-Learning site.
- o All students are assigned to prepare to address questions posed by facilitators.
- A grade sheet detailing facilitator and participant guidelines will be posted on the course E-Learning site.

### • AEA Readings/Discussion

- All AEA readings and discussions will take place as a class during scheduled class periods.
  Students are expected to:
- o Bring printouts or an electronic device to access readings each week.
- o Fully engage in reading sections out loud, commit to working through contractual language, and to participate in discussions prompted by instructor or peers.
- o Promote class dialogue and ask questions if anything is unclear.
- O A grade sheet with additional details will be posted on the course E-Learning site.

### • **AEA Interactive Game Project** (to be accomplished as a class)

- Develop a board game, game show, or other type of interactive activity focusing on AEA LORT Rule #51 Rehearsal, Performance, and Other Work Related Rules, Rule #64 Stage Managers and Assistant Stage Managers, and other AEA facts or trivia.
- o Find 5-10 AEA members and/or SoTD students, faculty, and staff that could potentially be employed under a current/future AEA contract (actors or stage managers) and invite them/confirm their participate. The game will take place on Friday, April 17 during class.
- O Consider your audience/participants when developing your game or interactive activity. Plan for a variety of skill levels.
- A grade sheet further detailing assignment parameters and a grading breakdown will be posted on the course E-Learning site.
