<u>Objectives/Goals</u>: To enhance students' understanding of and performance capabilities of flute repertoire (including solo literature, etudes, and orchestral excerpts) through regular practice, lessons, peer reviews in studio class, and research. To develop musically and professionally through study of appropriate interpretation, phrasing, articulation, tone production, posture, and historical style.

<u>Materials</u>: Students will need a flute, music stand, metronome, tuner, original copies of assigned music, and a computer appropriate for online lessons. Students should also maintain a notebook (hand-written or digital) of practice and lesson logs. There is no required text for this course, each student will be learning different solos and etudes.

**Description**: Each student will receive one 50-minute individual lesson each week (a total of 13 lessons). Music majors will have lessons with Dr. Stoner and minors will study with Ms. Mess. Students should practice regularly and have all assigned materials prepared prior to the lesson time. The entire flute studio will meet online on Mondays, 6<sup>th</sup> period, to work on performance skills. **Attendance at these classes and at all lessons is mandatory**. Music majors are also expected to attend scheduled convocations on Fridays 6<sup>th</sup> period.

<u>Students may choose to have all lessons online, or to have mostly online lessons with live meetings (with safety regulations) when possible.</u> \*

<u>Cancelled lesson policy</u>: If a student feels unprepared or needs to cancel just prior to a lesson, the student forfeits that lesson time with no chance for a make-up lesson. If a student cancels a lesson more than 24 hours in advance due to illness or emergency, the professor may make up the lesson at her discretion and availability. Occasionally the professor may have obligations, such as performances or recruiting, which will require her to reschedule lessons with students.

Whatever the reason, if a student knows he/she will miss a lesson, the

**professor** <u>must</u> be contacted prior to the lesson time. Be aware that canceling lessons for reasons other than illness or family emergency may affect your grade. **Requirements**:

- preparedness for and attendance of each lesson (regular practice outside of lesson required, ideally 2 hours a day for majors and 1 hour a day for minors) For students who have trouble managing their practice time, weekly practice reports may be required by the professor as part of the lesson grade
- attendance of flute studio class, convocations, and student recitals during 6<sup>th</sup> period
- 3. attendance of **all flute recitals** students, faculty, and guest artists. If you must miss a flute-related event, contact Dr. Stoner as soon as possible to determine if your absence will be excused.
- 4. each student in flute studio must play a jury at the end of each semester, unless he/she has given a solo recital during the semester
- 5. students will write constructive comments for performers in flute studio class
- 6. All studio members will perform on at least one recital during studio class.
- 7. students will listen to available recordings of works they are studying this will be included in lesson preparation grade
- 8. note not all lesson assignments will be performance-based. If a text or article is appropriate to the repertoire being studied, it may also be assigned and included in the lesson preparation grade
- 9. if a student is planning a recital, follow the School of Music Guidelines for recital programming, in consultation with your professor.
- 10. Behave professionally and respectfully in the School of Music (classes, rehearsals, and performances) as an ambassador of the UF Flute Studio.
- 11. Cell phones must be turned off during all events, including lessons and studio class.
- Maintain notes detailing practice sessions (time/day/goals/accomplishments), listening log, and lesson comments.

# <u>Special Project this Semester:</u> FLUTE VIDEOS USING ACAPELLA:

Students will create and upload a video to YouTube using the app Acapella. The video must combine at least two videos of you playing the flute (a duet with yourself) – anywhere up to a whole flute choir of yourself! You may use preexisting music, classical or popular or whatever, or you may make an arrangement of your favorite song, etc. The video must be at least 3 minutes long. The purpose of this assignment is to learn the importance of *playing in tune* in an ensemble setting! The studio will vote on projects to win \*BEST VIDEO and \*FUNNIEST VIDEO. *Email* a link to your uploaded video to Dr. Stoner by November 30th at midnight EST (you may have the video set as *public* or *unlisted*). We will watch the videos in studio class on December 7<sup>th</sup>.

# **Grading:**

50% Lesson preparation (weekly grades given at each lesson)

20% Jury or solo recital (average of grades given by faculty)

30% Studio class: attendance/preparation, Studio Recital performance, attendance of required flute events, and Acapella video project.

Please note: only consistently EXCEPTIONAL work will be awarded a grade of A. If you are in doubt about your current grade, please consult with Dr. Stoner.
