OBJECTIVES

The purpose of this course is to expand artistic consciousness through presented research and investigated research at the intersection of society, politics, history, economy, individualism, and clothing. We will investigate beyond traditional western stages: investigating theatrical costume design and the application of history as a tool of visual communication. This course is aimed to challenge and expand student beliefs while rooting each student in their own ancestral past within the context of historical costume.

PROJECT DESCRIPTIONS

THIS IS US is a personal exploration of ancestry and the intersection with history and clothing. The goal is to help you answer the question "Who Am I?" by linking yourself to an individual, moment, or period of your ancestry. Each student will select an individual, period, or moment from their own familial history to research the historical, political, economical, and cultural details. Students will then tell the story of their selection visually, verbally, and through writing. This project is completed in parts over the course of the entire semester. Please see Course Calendar for multiple check-in dates.

Visual: Let your creativity shine. As a community we will create a website to feature your work. Visual format can include photos, videos, collages, renderings - your imagination is the limit! All images should represent accurate historical details and follow proper research methods.

Verbal: During the semester we will tell the story of our exploration and findings. The final class period every student will have the opportunity to present their ancestral story to the class.

Writing (4 pages/2000 words): This should be considered a research report. You should use information from your annotated bibliography to tell the history and link the ancestry to your present. You will be evaluated with respect to grammar, punctuation, clarity, coherence, and organization

WORN ON THIS DAY: Monday through Friday for the duration of the semester, students will receive a brief, automated email detailing a significant historical garment. Students will select 5 of the emails to reply to posted canvas discussion. Canvas discussion will be initiated on Mondays of each week and will remain open for reply for 7 calendar days.

ONLINE CONTENT: Due to Covid-19, one class period per week, you will complete asynchronous online content to prepare for in person meetings. Asynchronous content will be opened weekly on Mondays for the following week. Content includes readings, videos, chats and quizzes. The content will be closed on Thursday end of day for the current week. Not completing this content will leave you unprepared for class discussions.

CRITICAL DISCUSSION will take place during each on campus meeting. Online course materials address topics that may be uncomfortable to some class members so it is important to attend all in class meetings with an openness to learning and participating.

RESEARCH PROJECT: The goal of this project is to collectively assemble the information (text and photographic) you would need to teach the standard Survey of Western Costume History cannon. Following the contents of Survey of Historic Costume, you will each be assigned chapters to read as a basis for your research. This research will need to be augmented with additional research particularly visual. The costume cannon typically addresses the following:

- social context
- Vocabulary
- Gender specific dress
- Notable designers or artists
- Dress layers from head to toe
- Wigs, hair, and makeup
- Accessories and shoes

All research should follow standards addressed in Research Methods module. Material should be compiled and presented with the idea that you would be giving an in-class lecture to an undergraduate BA/BFA Theatre student. Submissions will be made via canvas and all students will have access to each other's finalized research presentation. It is unnecessary to work as a group but this is welcome if students desire this type of interaction. If so, each student is solely responsible for completing assigned research.



CAMPUSWIDE POLICY FACE COVERINGS

- Cover your mouth and nose with a face mask or cloth face covering when around others.
- Wear a face mask/cloth face covering when around others or out in public for example, in the common area of an office suite or in the restroom, at the grocery store or when picking up other necessities, etc.
- Do not place a face mask or cloth face covering on children under age 2 or on anyone who has trouble breathing or is unconscious, incapacitated or otherwise unable to remove the mask without assistance.
- A face mask meant for a health care worker (N95) is not necessary, unless you are in a setting where there is the potential for direct exposure to a person/persons infected with COVID-19.
- Continue to keep about 6 feet (2 meters) between yourself and others.
- Note that the face mask/cloth face covering is not a substitute for physical distancing.

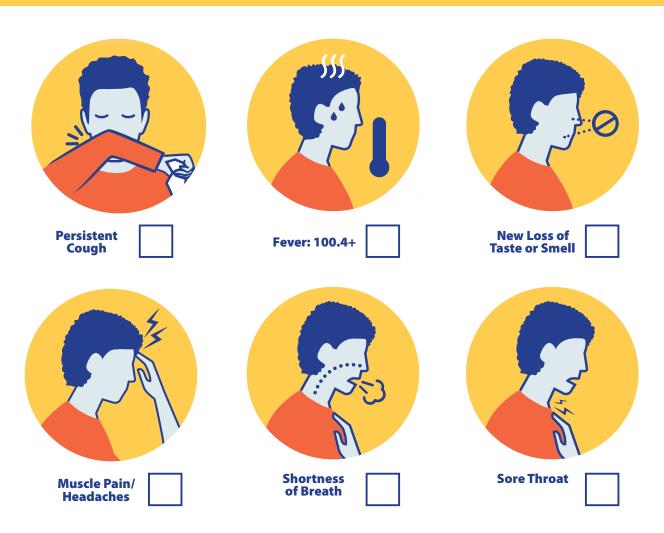
