Attendance Policy. Attendance is critical to your success in this class. The following policies apply:

Zoom policies.

I strongly encourage students to have their video on during class. It is not required, as there are any number of valid technical and personal reasons why one may not wish to do so. But I urge you have your video on if possible, as I believe it will help you in many ways. It will be much easier for us to get to know you and understand you as a student if we can put a face with the name. It will help you to stay engaged in class, and will help make the virtual classroom more “real” and feel like a community.

Our class sessions may be audio visually recorded for students in the class to refer back and for enrolled students who are unable to attend live. Students who participate with their camera engaged or utilize a profile image are agreeing to have their video or image recorded. If you are unwilling to consent to have your profile or video image recorded, be sure to keep your camera off and do not use a profile image. Likewise, students who un-mute during class and participate orally are agreeing to have their voices recorded. If you are not willing to consent to have your voice recorded during class, you will need to keep your mute button activated and communicate exclusively using the “chat” feature, which allows students to type questions and comments live. The chat will not be recorded or shared. As in all courses, unauthorized recording and unauthorized sharing of recorded materials is prohibited.
