<u>Objectives/Goals</u>: To enhance students' understanding of and performance capabilities of flute repertoire (including solo literature, etudes, and orchestral excerpts) through regular practice, lessons, peer reviews in studio class, and research. To develop musically and professionally through study of appropriate interpretation, phrasing, articulation, tone production, posture, and historical style.

<u>Materials</u>: Students will need a flute, music stand, metronome, tuner, original copies of assigned music, and a computer appropriate for online lessons. Students should also maintain a notebook (hand-written or digital) of practice and lesson logs. There is no required text for this course, each student will be learning different solos and etudes.

<u>Description</u>: Each student will receive one 50-minute individual lesson each week (a total of 13 lessons). Music majors will have lessons with Dr. Stoner and minors will study with Ms. Mess. Students should practice regularly and have all assigned materials prepared prior to the lesson time. The entire flute studio will meet online on Mondays, 6th period, to work on performance skills. **Attendance at these classes and at all lessons is mandatory**. Music majors are also expected to attend scheduled convocations on Fridays 6th period.

<u>Students may choose to have all lessons online, or to have mostly online lessons with live meetings (with safety regulations) when possible.</u> *

<u>Cancelled lesson policy</u>: If a student feels unprepared or needs to cancel just prior to a lesson, the student forfeits that lesson time with no chance for a make-up lesson. If a student cancels a lesson more than 24 hours in advance due to illness or emergency, the professor may make up the lesson at her discretion and availability. Occasionally the professor may have obligations, such as performances or recruiting, which will require her to reschedule lessons with students.

Whatever the reason, if a student knows he/she will miss a lesson, the

professor <u>must</u> be contacted prior to the lesson time. Be aware that canceling lessons for reasons other than illness or family emergency may affect your grade. **Requirements**:

- preparedness for and attendance of each lesson (regular practice outside of lesson required, ideally 2 hours a day for majors and 1 hour a day for minors) For students who have trouble managing their practice time, weekly practice reports may be required by the professor as part of the lesson grade
- attendance of flute studio class, convocations, and student recitals during 6th period
- 3. attendance of **all flute recitals** students, faculty, and guest artists. If you must miss a flute-related event, contact Dr. Stoner as soon as possible to determine if your absence will be excused.
- 4. each student in flute studio must play a jury at the end of each semester, unless he/she has given a solo recital during the semester
- 5. students will write constructive comments for performers in flute studio class
- 6. All studio members will perform on at least one recital during studio class.
- 7. students will listen to available recordings of works they are studying this will be included in lesson preparation grade
- 8. note not all lesson assignments will be performance-based. If a text or article is appropriate to the repertoire being studied, it may also be assigned and included in the lesson preparation grade
- 9. if a student is planning a recital, follow the School of Music Guidelines for recital programming, in consultation with your professor.
- 10. Behave professionally and respectfully in the School of Music (classes, rehearsals, and performances) as an ambassador of the UF Flute Studio.
- 11. Cell phones must be turned off during all events, including lessons and studio class.
- 12. Maintain notes detailing practice sessions (time/day/goals/accomplishments), listening log, and lesson comments.

Special Project this Semester: ETUDE COMPOSITION AND RECORDING:

Students will create an original etude of at least 32 measures (hopefully longer). The etude should focus on some technique or issue that is a particular challenge for the student. Style, tonality (or lack thereof), tempo, and techniques are completely up to the composer. The etude should be notated in detail (articulations, dynamics, etc) using your choice of music notation software. Once the etude is composed, the student will record a video performance of their new etude and upload the video to YouTube (you may have the video set as *public* or *unlisted*). The final submission, due by midnight on April 9, 2021, should include a PDF of the etude and a link to the YouTube video emailed to Dr. Stoner. Studio members will watch all of the videos during studio class on Monday, April 12. We

will also electronically "publish" a collection of all of the etudes for everyone to learn and enjoy. The purpose of this assignment is to 1) do some self-reflection about what our specific challenges are on the flute, 2) brainstorm ways to strengthen those weaknesses, 3) stretch our brains by composing something entirely new, and 4) become stronger by mastering our weakness. Have fun composing and performing! You can always ask for help with ideas and such.

Grading:

50% Lesson preparation (weekly grades given at each lesson)

20% Jury or solo recital (average of grades given by faculty)

30% Studio class: attendance/preparation, Studio Recital performance, attendance of required flute events, and etude composition project.

Please note: only consistently EXCEPTIONAL work will be awarded a grade of A. If you are in doubt about your current grade, please consult with Dr. Stoner.
