General Information

Description

Utilizes draping techniques to create garments. Draping is one of the two basic methods used to create patterns for theatrical costumes, the other being flat pattern drafting. In this course students will learn how to create basic pattern shapes, also called slopers, using the draping method. This is done by draping fabric directly on dress forms and manipulating it to achieve the desired shape.

Expectations and Goals

By the end of this course students will be able to understand and put into practice:

- The fundamentals of draping patterns on the dressform
- The fundamentals of flat pattern manipulation, including slash and spread techniques and basic drafting principles
- The fundamentals of truing the muslin drape, adding notches, and accurately transferring pattern pieces to paper
- Cutting and constructing a muslin mockup
- Application of these fundamentals to a final project in the form of draping a dress design assigned by the instructor, completed as a muslin mockup

Course Materials

Required Materials

Each student is required to provide the following materials:



- 12 yards medium weight muslin, 45" to 60" wide
- #2 pencils (NOT mechanical) and/or felt tip markers (NOT permanent, Pentel or Pentech brand is recommended)
- Fabric shears
- Thread snips

Recommended supplies for pattern truing at home

- 18" clear plastic ruler
- Set of metal fashion rulers including: tailor's square, hip curve, French curve

All homework must be completed on full-scale dress forms in the costume shop. Half scale dress forms may be checked out by any student who feels they would benefit from being able to practice at home. Half scale practice is not a replacement for completing the work at full scale and will not be accepted in lieu of the full scale draping homework assignment.

Additional Information and Resources

Attendance Policy, Class Expectations, and Make-Up Policy

Students are expected to stay home and seek medical help for COVID-19 symptoms or exposure (persistent cough, fever 100.4+, new loss of taste or smell, muscle pain/headaches, shortness of breath, sore throat, chills, diarrhea, or feeling generally ill). The culture of hiding illness or the "show must go on" mentality must be avoided. Students who are medically required to quarantine will have documentation from a medical provider. That documentation must be submitted to the instructor in a timely fashion. Students who self-quarantine must communicate with the instructor and "attend" courses remotely synchronously, when available, or asynchronously if approved by the instructor.

Students who elect to enroll in an in-person course are expected to participate in in-person instruction. If a student is uncomfortable attending in-person, the student should elect courses that are delivered online only and plan to take the hybrid or face-to-face course in a future semester. In the case that the student does not have the option to take the class at a later time (i.e. a graduating senior), the student must make arrangements with the instructor to "attend" all class meetings synchronously, when available, or asynchronously if approved by the instructor.

Barring the above circumstances, students are expected to be in attendance (either remotely or in-person, as assigned) daily and to be on time. Students are allowed 1 "unexcused" absence that does not require documentation and does not conform to the UF "acceptable reasons for absence." Any other "unexcused" absence will result in a penalty of a full letter grade (10%) from the final grade per "unexcused" absence. To be considered "excused" an absence must be accompanied by appropriate official documentation. Religious observances do not require documentation.

Any absence from class for the following reasons must be supported by official acceptable documentation to avoid a grade penalty:

• Illness—doctor's note must be on official letterhead with address and phone number, noting the date and time of visit and diagnosis verifying that an absence from class is warranted, doctor name and signature



- Serious family emergencies
- Special curricular requirements (e.g., judging trips, field trips, professional conferences)
- Military obligation
- Severe weather conditions
- Participation in official university activities such as music performances, athletic competition or debate
- Court-imposed legal obligations (e.g., jury duty or subpoena)

To help organize accommodations, students should inform the instructor by the end of the second week of classes of religious observances of their faith that will conflict with class attendance this semester.

Any student that acquires 3 absences (either excused or unexcused) will be required to meet with this course's instructor and/or area faculty to discuss the student's continued participation in the course.

In-Person Class Guidelines

We will have face-to-face instructional sessions to accomplish the student learning objectives of this course. In response to COVID-19, the following policies and requirements are in place to maintain your learning environment and to enhance the safety of our in-classroom interactions.
