- Conduct research, technical experimentation, pre-visualization, and rapid prototype construction as part of the pre-production development phase.
- Write industry-standard development documentation; Game Design Document, Technical Design Document, and the Art and Animation Style Guide.
- Engage project and milestone scheduling using task tracking software.
- Collaborate in a team-oriented creative production environment.
- Complete a portfolio-quality cutting-edge completed game product.

We value participation more than mere attendance. In our course, attendance is taken at the beginning of each class period, and is calculated as the Participation element which makes up 10% of your overall grade. Any unexcused absences are factored into the Participation grade total. All assignments are due by the stated date and time. Late assignments as a result of an unexcused absence may be submitted up to one week after the scheduled due date, incurring a 10% grade penalty.

Our class sessions may be audio visually recorded for students in the class to refer back and for enrolled students who are unable to attend live. students to explore themes and tell stories that may include this difficult subject matter, they should be cautioned against modes or styles of representation that might be considered unnecessarily offensive or potentially triggering.

Instructors, faculty, and university administrators reserve the right to not show or share any student work they feel is inappropriate for their classroom or for public exhibition, as there may be concerns about the impact of such work on the community. We encourage students to consult with their faculty when producing work that might be considered controversial, and to err on the side of being cautious when it comes to making decisions about a project's content - in other words, make the PG-13 version of your story, not the R version, and certainly not the "unrated" version. This is also to help students understand that most professional creative situations have strict guidelines and limitations on such content and how it is produced: your ability to tell stories effectively with "less" is a strong professional skill that will aid in the dissemination of your work to a broader audience.
