# **Course Description**

Percussion studies, including studio class and applied lessons, are designed to develop the highest level of musicianship, artistry, and teaching proficiency within a total percussion curriculum. Students are presented with a progressive sequence of learning objectives adapted to the needs of each individual. The understanding and development of technical facilities, sight-reading skills, and ensemble applications are required on each instrument, in addition to regular performances in studio classes, clinics/masterclasses, and juries.

## **Studio Expectations**

Percussion studio class takes place every Wednesday at 12:50pm in MUB 233A, August 25-December 8. Students are expected to perform at least twice per semester, and may be assigned projects or topics to be presented during the class. The semester grade will in part be determined by studio preparedness and attendance.

### **Lesson Expectations**

Lessons are individually scheduled with the instructor and will take place in MUB 233A. Students will arrive on time for their lesson, fully warmed-up and ready to play. It is essential that all students spend at least two hours per day (outside of rehearsals) practicing. Make-up lessons will be scheduled at the convenience of the instructor in the case of illness or university-related events. Students should keep a "practice journal" or similar notebook detailing weekly progress and concepts discussed in lessons. The semester grade will in part be determined by weekly lesson preparedness and attendance.

### **Attendance**

Attendance is required for all scheduled lessons, convocations, studio classes, clinics/masterclasses, and other percussion events. Each unexcused individual lesson or studio class will count for 2% off the overall grade. Students must notify their instructor of any conflicts as soon as they are known, and lesson/studio absences at least 24 hours in advance. Excused absences are approved at the discretion of the instructor.

#### Juries

Juries will take place at the end of each semester and serve as the final exam for the course. Selections will be chosen by the instructor and based on student progress throughout the semester. A percussion jury is required of all students excepts those giving recital during that period. More details will be provided as the end of the semester approaches.

# **Required Materials**

All necessary materials (mallets, sticks, texts, music, etc.) will be supplied by the student and determined in collaboration with the instructor.

Publication without permission of the instructor is prohibited. To "publish" means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is

posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third-party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
