Research for Doctoral Dissertation

To conduct research for doctoral dissertation, and (when ready) to make progress on writing.

Week 10: Research and/or Writing/ Revisions if required by the committee.

Week 16: Submit Summary of Research Progress or Submit any drafts completed / Meet with Advisor as necessary; complete formatting corrections required by editorial office.
