COURSE DESCRIPTION

This course explores the process of 35mm Black and White darkroom photography. Through camera handling, negative development, wet darkroom processes, and image enlargement, students will move through the process of shooting, developing, exposing, and enlarging 35mm images.

Alongside this technical development, students will develop a workflow rooted in visual research, supported by texts, historical and contemporary artist references, in-class critiques, and peer discussions, as well as one-on-one meetings with the professor. This is a hands-on course that frames photography as a praxis of research, practice, and presentation.

COURSE OBJECTIVES

Through individual projects, critiques, visual research, and discussion-based participation students will:

- Learn and deploy skills to make Black and White 35mm photo negatives and enlargements
- Practice working in wet darkrooms developing and enlarging photo negatives through chemical-based workflow to produce prints
- **Develop** a working language around terms, ideas, and issues pertinent to analog photography, and the history image-making as it relates to 35mm photographs
- Size, scale, and print original images in UF's wet darkrooms
- **Prepare** and **present** work for in-class critiques, and **engage** with peers and professor during critiques and in-progress workshops
- Perform visual research and present alongside in-progress and completed projects

METHOD OF INSTRUCTION

This course consists of in-person classes focused on lectures + discussions, at-home workdays, in-class work/lab sessions, an project critiques. There are three projects in this class:

PROJECTS:

- 1. Simulation and Simultaneity
- 2. Making Alternativity Real
- 3. You, Seeing Me, Seeing You

Each project will include specific instructions and project parameters, in addition to grading criteria. Additionally, two core objectives of this course include performing visual research and engaging in critiques.



GRADING INFORMATION

There are three projects in this course, six in-progress material or research deadlines, and critiques. Students will be graded on their participation, completion, and success across each of these course components.

PROJECTS (3 total) Includes visual research, in-progress work, critiques, and preparedness.	20% per project (60% total)
READINGS + HOMEWORK (3 total) Includes in-class discussions, in-progress work	25%

CRITIQUES

It is a requirement of this course that you participate fully in critiques. Because of the collective aspect of the critique, it is mandatory that you are present at all three critiques. A portion of your grade will come from your contributions in critique. Everyone is expected to participate verbally (or in written form, as discussed with the professor beforehand) during critique. Your participation in this class is imperative, and robust student participation is expected. Students must be present for the final critique in order to receive credit for their final project. Please plan travel accordingly, as critiques cannot be rescheduled.

VISUAL RESEARCH

Performing visual research is a core objective of this course. Visual research is the process of conducting research through expanded media, including but not limited to: artworks, scholarly articles, studio work, interviews, dictionary definitions, gallery exhibitions, archives, etc. Visual research asks you to clarify the terms of engagement (i.e. "uncanny) in addition to specifying why you deployed certain strategies to create your work.

Your practice in this course involves the production of artworks, which are informed by contemporary and historical references that, in turn, help you present the work during critique in in a grounded context.



LATE WORK

All work must be submitted on time for full credit. If there are extenuating circumstances that inhibit a student from fully completing their work, they must provide documentation showing that they were unable to finish their work. On a case-by-case basis, exceptions may be made.

REQUIRED READINGS

There are no required texts for this course. All readings will be available via email through our course listserv. Films and Media will be available through the AFA library on course reserve, or accessible through Kanopy or Vimeo.com

REQUIRED MATERIALS

- 1. Every student should have access to an SLR camera with manual exposure controls. Canon AE-1 or Pentax K1000 are the recommended cameras.
 - a. Any film-based camera with manual exposure controls is acceptable, and a stock lens works. The recommended lens length is 50mm, but other lens lengths are acceptable. Please check with the professor before purchasing cameras (new or used), and any additional lenses. Be sure to have a fresh battery in your camera, which will operate your light meter.
 - b. Analog SLR (PENTAX K1000 and Canon AE-1) cameras are available for checkout through the photography cage in FAD, but they are on a first-come, firstserve basis.
- 2. Twenty (20) rolls of Black and White Film (36 exposures)
 - a. Recommended films include Ilford HP5 or Kodak Tri-X. Kodak TMax can be used.
- 3. 35mm Negative Sleeves and Notebook for Storing Negatives/Sleeves
 - a. Recommended size + orientation → 35mm, 7 strips of 6 frames
- 4. Fiber-Based (FB) Enlargement paper
 - a. Size \rightarrow 11" x 14", 150 sheets minimum.
 - b. Recommended paper: Ilford Multigrade FB Classic Paper (Glossy or Luster), purchase three packs of 50

ATTENDANCE POLICY

Attendance for in person class periods is determined by your physical presence.
