
Creative Process for Actors

COURSE DESCRIPTION

This is a course in performance process. It will guide actor-artists on how to integrate performance, theatre, film, and art theories into their personal process for creative performance practice and how to work as a "Research-Creative." This course proposes that the actor-artist can creatively and uniquely respond to, and/or influence, the cultural zeitgeist. This course includes the exploration of art, music, science, data, anthropology, mythology, and popular culture as inspirational touchstones for storytelling; it includes the use of creative lab/modular experiences to refine a dynamic creative response to the artists' environment.

COURSE OBJECTIVES

- 1. To develop an integration of the actor's training into personal creative practice.
- 2. To explore and define what is a "research-creative" performer.
- 3. To provide students with various theoretical frameworks that expand their knowledge base of "performance."
- 4. To provide students with exposure to performance, theatre, and film artists who expand and redefine the accepted definition of "performance" and "theatre."
- 5. To explore and develop a working knowledge and vocabulary of the researchcreative process of theory > research > praxis.
- 6. To explore and develop a personal creative response to three-step process of "thinking," "seeing," and "doing."
- 7. To learn to apply non-theatre processes (Systematic Inventive Thinking, IDEO's brainstorming, ...) in theatrical ways.
- 8. To learn the "rules" of creative practice theories and subsequently learn when to break the rules with creativity and mastery.

REQUIRED TEXTBOOKS

All required readings will be provided by instructor throughout the semester as assigned.

CONTENT DISCLOSURE

In this course, we will cover content and materials that some may find difficult. It is important that in a theatre/performance skills course we do not shy away from engaging with materials that may be controversial or challenging. I will do my best to give you advance notice when specific materials or content covered may contain images, language or perspectives that some may find difficult, and I encourage you to reach out to me if you are struggling with the course materials. In class, if you need to step away for a period of time as we are covering particular content, you may do so without penalty, but I ask that you remember that you are responsible for any information covered in your absence.

Students are encouraged to employ critical thinking and to rely on data and verifiable sources to interrogate all assigned readings and subject matter in this course as a way of determining whether they agree with their classmates and/or their instructor. No lesson is intended to espouse, promote, advance, inculcate, or compel a particular feeling, perception, viewpoint or belief.

DECORUM

Your work in class is a major part of your grade. This includes your classroom and out of class rehearsal decorum because it strongly impacts the quality of instruction for you and your collaborators. You are expected to show respect for yourself, your partners, and the art and craft of performance. You are also expected to respect the spaces in which we work by preparing the space for work and clearing it after you finish working. Part of learning the acting process is also learning how to act professionally. Unprofessional conduct will not be tolerated.

** Food is not permitted in class. Eat before or after class, not in class.

TEACHING METHOD

There will be assigned readings and discussions of text materials, practical exercises, and research. There will be studio "lab" work that is participatory by nature. The unique nature of creative process requires investigating different ways of seeing yourself and the world.

Your responsibility is to be prepared and present, let go of what you think you should "do," and respond from an authentic place. Be willing to integrate the theory, process the research, try the exercises, take the professor's notes, suggestions, and directions in a collaborative fashion.

Course Requirements: Full participation in class exercises. Students are expected to be prepared to work in class as a "lab" experiment.

Various modules and exercises will be explored to see what they provide us as creative artists. Reading must be completed on time, in order to have fuller conversations and discussions in class. Sometimes, work will be assigned to be executed outside of class and then presented in class (whether written or performative). This work cannot be done late, unless there are extreme circumstances which we can speak about in private should the occasion arise.

GRADING

Grading will be evaluated and will be based on methods and requirements listed above, as well as quality of work, approach, enthusiasm, development, completion of all assigned work, and the student's ability to express written and oral knowledge concerning the course topics. Final grades will be based on above criteria, evaluation and assessment of each student's attitude toward the work, and the individual development of each student throughout the semester.

WRITTEN WORK

All papers and written assignments must be typed and presented on due dates. Late assignment and papers will be given only partial credit. Partial credit runs as follows: up to two days late: -10% of grade; up to four days late: -25% of grade; up to one week late: -40% of grade. NO assignments accepted after one week late.

MAKE UP WORK

Assignments must be presented on time. You will not be able to receive a "make up" grade except under extenuating circumstances at the judgment of the instructor. Because the course depends on the co-operation of collaboration and processing, it is imperative that work be presented ON TIME. In the event that an absence is known <u>in advance</u>, you must make arrangements to present the work early.

ATTENDANCE POLICY

University Attendance Policy

Students are responsible for satisfying all academic objectives as defined by the instructor. Absences count from the first-class meeting.

Acceptable reasons for absence from or failure to engage in class include illness; Title IX-related situations; serious accidents or emergencies affecting the student, their roommates, or their family; special curricular requirements (e.g., judging trips, field trips, professional conferences); military obligation; severe weather conditions that prevent class participation; religious holidays; participation in official university activities (e.g., music performances, athletic competition, debate); and court-imposed legal obligations (e.g., jury duty or subpoena). Other reasons (e.g., a job interview or club activity) may be deemed acceptable if approved by the instructor.

For all planned absences, a student in a situation that allows an excused absence from a class, or any required class activity must inform the instructor as early as possible prior to the class. For all unplanned absences because of accidents or emergency situations, students should contact their instructor as soon as conditions permit.

If a student does not participate in at least one of the first two class meetings of a course or laboratory in which they are registered, and they have not contacted the department to indicate their intent, the student can be dropped from the course. Students must not assume that they will be dropped, however. The department will notify students if they have been dropped from a course or laboratory.

The university recognizes the right of the instructor to make attendance mandatory and require documentation for absences (except for religious holidays), missed work, or inability to fully engage in class. After due warning, an instructor can prohibit further attendance and subsequently assign a failing grade for excessive absences.

Course Attendance Policy:

You are expected to be in class daily and to be on time. Each class meeting is worth 2 points. An "unexcused" absence will result in a loss of 2 points for that day. To be considered "excused" an absence must be accompanied by appropriate official documentation (religious observances do not require documentation). EACH late arrival (after professor takes roll), counts as a loss of 1 point for that class meeting date. Be sure to keep track of your own attendance. I will take attendance on Canvas **at the top of each class meeting**.

Any absence from class for the following reasons must be supported by official acceptable documentation to avoid a grade penalty: illness (doctor's note must be on official letterhead with address and phone number, noting the date and time of visit and that an absence from class is warranted, date of return to class, doctor name and signature), serious family emergencies, special curricular requirements (e.g., judging trips, field trips, professional conferences), military obligation, severe weather conditions, participation in official university activities such as music performances, athletic competition or debate, court-imposed legal obligations (e.g., jury duty or subpoena).

To help organize accommodations, students should inform the instructor by the end of the second week of classes of religious observances of their faith that will conflict with class attendance this semester.

Any student that acquires 3 absences (either excused or unexcused) will be required to meet with this course's instructor and/or area faculty to discuss the student's continued participation in the course. Failure to attend this meeting will result in Artistic Probation.

Due to the participatory nature of the course that includes in-class collaboration along with partner and ensemble work, if a student acquires more than 2 unexcused absences, the student may be prohibited from participation in partner/group exercises which will affect the student's final grade.

Participation in Hippodrome theatre productions (MFA acting):

If a student is cast in a Hippodrome production and they are on a typical rehearsal schedule, then students will likely miss 4 classes (2 weeks of Tues/Thurs or Wed/Fri classes), in some cases rehearsals might extend into 3 weeks (potentially resulting in 2 more absences of Tues/Thurs or Wed/Fri classes). In this instance, faculty will not penalize the student for the absences. Absences incurred due to Hipp productions absorb all "unexcused" absence allowances in any course attendance policy.

*MFA Students can be in one production per semester that interferes with courses (whether taught or courses they are teaching).

Students are responsible for notifying their SoTD instructor about casting in a Hippodrome

production. In instances where matinee productions interfere with class meetings, a clear conversation about missing those additional classes should be had with the course instructors. The total number of classes missed due to rehearsals, costume fittings, media promotions, and performances may prohibit students from progressing successfully in the course. An excess of 6 total absences due to a rehearsals and production related activities may result in a grade reduction up to and including a failing grade.

<u>This Hippodrome attendance policy applies to SoTD courses only.</u> Students are responsible for notifying instructors of non-SOTD classes and will need to adhere to the attendance policies of non-SOTD classes.

CELL PHONES AND OTHER ELECTRONIC DEVICES

These must be turned off before the beginning of each class. It is strongly recommended that they be turned off before entering the classroom.
