# **Course Description**

This course includes supervised teaching of graduate student instructors (GSIs) in a classroom setting. Teaching responsibilities are based on the GSI's GA or TA assignment for the semester.

# **Course Objectives**

- To provide mentorship of and feedback to GSIs regarding their teaching.
- To have GSIs reflect upon and improve their teaching during the semester.

## **Required Texts**

No textbooks or materials are required for the course. GSIs teaching large-enrollment classes, and particularly breakout sections, must follow the same reading schedule as the students enrolled in the class.

### **Course Schedule**

GSIs teaching large-enrollment classes, and particularly breakout sections, must follow the same meeting schedule as the students enrolled in the class. Due to the individualized nature of this course, an evaluation schedule will be agreed upon by the GSI and the primary instructor.

The primary instructor will observe each GSI twice during their assigned classroom teaching times. Teaching observations will be pre-scheduled, not at unknown times, and followed up by written feedback on the observed teaching. Meeting times to discuss teaching observations will be scheduled to discuss written feedback and provide guidance and mentorship to each GSI. During these meetings, the GSI will provide a brief aural reflection on their teaching.

# **Course Evaluation/Grading**

It is expected that written and verbal feedback from the primary instructor will help shape adjustments and/or improvements to the GSI's teaching as the semester progresses. It is also understood that goals/progress evaluation will not be the same for all students. Evaluation will be consistent with, and reflective of each GSI's ability level.

GSIs may inquire about their progress at any point in the semester. They may also request additional observations, if they feel it would help them improve their teaching.

A Satisfactory grade will be awarded if:

- The GSI successfully performs their teaching duties as required by their GA or TA assignment. This includes attending primary lectures in classes with breakout sections.
- The GSI schedules and attends meetings to discuss their teaching observations.
- The GSI provides a brief aural reflection on their teaching during the meetings that discuss their teaching observation.
- The GSI clearly incorporates feedback and works to improve their teaching during the course of the semester.

An Unsatisfactory will be awarded if one or more of the following occurs:

- The GSI does not successfully perform their teaching duties as required by their GA or TA assignment. Duties include attending primary lectures in classes with breakout sections.
- The GSI does not schedule or attend meetings to discuss their teaching observations.
- The graduate student instructor provides no reflection on their teaching.
- The GSI does not incorporate feedback to improve their teaching during the course of the semester.

### **Course Policies**

**Attendance**: If teaching breakout sections for a large-enrollment class, GSIs must attend the lecture portion of the class in addition to teaching their breakout sections.
