In your Senior Project, YOU will take charge of YOUR interests and goals as an artist and a thinker to probe the relationship between dance and other fields and make a fresh contribution to the field of dance! As your advising professor, I am thrilled and honored to support your quest!

# **BA Senior Project Description**

- Senior Project (SP) is the capstone course for all BA dance students. The SP is an original research initiative, which culminates in a written paper, determined by the student in consultation with a dance faculty member and subject to approval by the dance area. The project is to innovatively merge the student's academic and dance interests. Take advantage of the open structure to the BA Senior Project, as it provides you with an unequaled flexibility to explore research areas. For example, the SP may serve you as a touchstone for post-graduation research, become a notable highlight in your resume, potentially publishable, and innovatively further the field of dance.
- The paper may be supplemented by a presentation, but a presentation is not required. Please **read further for** more information on optional BA presentations.

### **BA Senior Project Summary**

- The year before you will enroll in Senior Project (typically the final semester of your third year):
  - √√ Select (or assigned) an advisor from the dance faculty (you may also seek a co-advisor from outside the dance faculty, if relevant to your topic);
  - √√ Establish and declare your research topic.
  - NOTE: You are required to establish and declare your research topic by the last two semesters before graduation (typically by the end of your final semester of your third year). If there are any issues with your topic, your dance faculty advisor will guide you through. Work with your advisor to meet requirements to complete your Senior Project registration form with complete information regarding topic and method of evaluation before submitting to Undergraduate Advisor.
  - √√ Choose to fall or spring semester of senior year to register for SP
- You are required to register for SP in fall or spring semester <u>only</u> (not both) and should be agreed upon with your advisor.
- The semester that you enroll in Senior Project
  - √√ Follow the BA Senior Project syllabus (The checklist is available in the Student Handbook)
- Available on the college website, the syllabus contains all deadlines and the evaluative process for final grading.
   √√ For research that uses human subjects

  - √√ If applicable, arrange presentation with the BA Coordinator and/or your advisor

### Senior Project 'Thesis' Paper

• The Senior Project paper is the final phase of your Senior Project and the articulation of your research in the prescribed format provided below. Unless otherwise cleared with your advisor, you are expected to follow the fall 2023 schedule below. Each step of the following processes brings you closer to an excellent final product.

#### SCHEDULE — Fall 2023 Paper Deadlines\* for submission to Senior Project advisor:

—OCTOBER 13, 2023 (Fri.) 5:00 PM: Three-part submission is due: (1) Revise and submit Abstract of approximately 250 words to summarize your topic and research findings. If it is helpful to you, you may write up to 500 words, but note that your final abstract which will be due with the formal submission of your thesis will be 250 words, maximum. Your abstract will become more focused as you move through your research and writing process—thus, changes are expected. (2) Submit your finalized Works Cited in MLA format (as required for your formal submission). (3) Then, in approximately one paragraph per source (you may write more, if your wish), summarize each source in approximately two sentences, then add how/why you plan to use this source in your paper—and, if desired, include useful quotes from the source—this step will be invaluable to you as you begin to write.

**NOVEMBER 3, 2023 (Fri.) 5:00 PM: Organizational Outline is due:** fill in one paragraph for each of the following four sections using the information and analysis you have developed so far. You can write a bit more, if you wish! The more thoughtfully you engage in this process, the smoother your writing will go. In fact, this part of the process shows you precisely WHERE your research is strong and WHERE gaps may need to be filled in. The sections for your Organizational Outline are: Introduction, Discussion of Literature, Methodology, and Outcomes. (These sections are cut and pasted directly from the RESEARCH PAPER REQUIRED FORMAT.)

- o Problem and Purpose Statement: who or what are you proposing to discover, challenge, understand, illuminate. Purpose of paper and what you seek to achieve in this writing.
- Rationale: what is important about this exploration? What contribution does it make to the field of dance?
- Personal Statement: Why is the subject important to you? Is there a personal connection to the subject; or a connection you would like to make?

☐ Two–page *Discussion of the Literature* and other resources you researched (written, visual, media).

Demonstrate your knowledge of what has been done before related to this topic. (Your annotations per source will support you here!)

☐ Two-page *Methodology* section describing the research process you undertook.

- Detail ideas and approaches showing WHAT you actually did.
- You may include HOW you made unique connections across (or unique use of) your selected "literature" (written, visual, media, etc.) and the questions these connections prompted for you.

☐ One-page *Outcomes, Reflections, and Future Directions* section, summarizing the most salient outcomes of your project and possible future directions of your research/project.

- The critical findings, results, or conclusions of the research, including strengths and weaknesses. What further questions do you have or what directions for research
- o What are the larger implications of your findings?

**NOVEMBER 17, 2023 (Fri.) 5:00 PM:** <u>First full draft is due</u> (Complete ALL SECTIONS due from Title Page to end in a first draft which meets required page lengths per section). Focus on getting your full content down on paper in draft form. In this first draft process, <u>the most important thing is getting it down!</u> You will have the chance to very carefully edit and refine your work for your second/final draft due on Dec. 8.

**DECEMBER 8, 2023 (Fri.) 5:00 PM**: <u>Second/final draft is due</u>. Incorporate all edits, then check Grammarly or other spell/grammar check and finalize before sending to advisor. Go through the checklist and be sure ALL sections are complete according to the content/page-length guidelines in the required format.

• Should a third draft be deemed necessary by your advisor, this would be accomplished during a timeline established between you and your advisor.

**DECEMBER 14, 2023 (Thurs. 5:00 PM) FINAL is due with all feedback and editing incorporated.** It is <u>your responsibility</u> to contact your advisor with any questions, concerns, or unanticipated schedule changes so that your advisor may take them into consideration. Note, advisors may not be available to answer emails on weekends, holidays, and some evenings—so it is your responsibility to communicate with plenty of time if you anticipate a problem.

☐ <b>Dedication</b> (roman numeral ii)

□ <b>Abstract</b> succinct overview of the paper (Write—or rewrite—after you have completed your paper) (roman numeral iv). An abstract summarizes the paper and is used by prospective readers to decide whether or not to read the entire text. Make it compelling and powerful reading (100-250 words maximum).
□ <b>Table of Contents</b> (roman numeral v). Use exact title of section on left and 1st page number of the section on right: include page numbers for dedication, acknowledgments, abstract, and section headers (but do not cite page numbers for title page or Table of Contents.
<ul> <li>One-page <i>Introduction</i> to topic (start numeral 1)</li> <li>Problem and Purpose Statement: who or what are you proposing to discover, challenge, understand, illuminate. Purpose of paper and what you seek to achieve in this writing.</li> </ul>

BA Paper with Presentation - Guidelines
The BA students' Senior Projects may have potential for presentation in diverse public fora but presentations are NOT required. A presentation may be a choreographed work or work-in-progress, teaching demonstration, documentary-style film. PowerPoint presentation, or other. The dance area will support you as resources allow. A presentation does not

film, PowerPoint presentation, or other. The dance area will support you as resources allow. A presentation does not replace the paper. Please note that a choreographed dance, done for its own sake, would not be approved as a viable BA Senior Project.

Please also note that there is no SoTD budget available for BA Senior Projects. If you do decide to include a presentation as a part of your grade, this presentation should be executed as professionally as possible, given the limited resources, and reflect the highest standards for academic/creative research.

Students with a viable presentation related to their research paper may have several options for exhibition:

- An alternate location associated with another college/program—such as the Harn Museum Nights, the Harn Museum of Dance, or other.
- Presentation through an existing group with another venue for presentation, such as the Center for Arts in Medicine (AIM), the VISA talent show, a UF student dance company, other UF Student Government approved organizations, etc.
- Depending on previously established priorities for scheduled *UnShowing's*, a limited opportunity for showing may
  be possible in consultation with the faculty member in charge of Unshowing and/or Dance Coordinators
  regarding available timeline. Please note that *UnShowings* do not receive technical support (lights, costumes,
  etc.); and if you are allowed to present, the Showing/Presentation would be limited to 12 minutes and allowed
  only minimal set-up (you may petition for a more in-depth/longer presentation).
- Other outlets/venues that you identify.

#### **Examples of previous successful BA presentations** (in conjunction with their research paper):

- >> PowerPoint presentation of creative work linked with Veteran causes and concerns.
- >> Documentary film using Laban Movement Analysis as a toolkit for women with Lymphedema.
- >> Dance Film creative and technical study.
- >> Presentation related to a University Scholars award.
- >> Creative work exploring and exhibiting the choreographer's concept of collaboration.

#### **Evaluation**

The general criteria for BA assessment will apply to the overall project and written paper. The BA Senior Project should be a clear and articulate integration of the student's areas of interest and studies in Dance as well as other major, minor, and certificate studies.

#### **Honors Thesis**

Depending on your approach to your quantitative, qualitative, and/or creative research, as well as you GPA, it is possible that this Senior Project paper could become the foundation for a research paper that will put you in good stead for graduation with high or highest honors should your GPA warrant such recognition. Your Dance History paper could be used similarly. This usually requires adapting or reconfiguring a portion of your creative research into a focused research topic. The Senior Project paper, by itself, would not be acceptable for this level of consideration. High/Highest honors papers also require a faculty mentor, as well as a second reader.
