<u>Objectives/Goals</u>: To enhance students' understanding of and performance capabilities of flute repertoire (including solo literature, etudes, and orchestral excerpts) through regular practice, lessons, peer reviews in studio class, and research. To develop musically and professionally through study of appropriate interpretation, phrasing, articulation, tone production, posture, and historical style. To develop lasting musical independence. To develop transferrable skills such as creativity, listening, adaptability, coping, confidence, and diligence.

<u>Materials</u>: Students will need a flute, music stand, metronome, tuner, original copies of assigned music, and a computer appropriate for online lessons. Students should also maintain a notebook (hand-written or digital) of practice and lesson logs. There is no required text for this course, each student will be learning different solos and etudes.

**Description**: Each student will receive one 50-minute individual lesson each week (a total of 13 lessons). Music majors will have lessons with Dr. Stoner and minors will study with Sydney Burton. Students should practice regularly and have all assigned materials prepared prior to the lesson time. The entire flute studio will meet on Mondays, 6<sup>th</sup> period, to work on performance skills. **Attendance at these classes and at all lessons is mandatory**. Music majors are also expected to attend scheduled School of Music convocations.

<u>Cancelled lesson policy</u>: If a student feels unprepared or needs to cancel just prior to a lesson, the student forfeits that lesson time with no chance for a make-up lesson. If a student cancels a lesson more than 24 hours in advance due to illness or emergency, the professor may make up the lesson at her discretion and availability. Occasionally the professor may have obligations, such as performances or recruiting, which will require her to reschedule lessons with students.

Whatever the reason, if a student knows they will miss a lesson, the professor <u>must</u> be contacted prior to the lesson time. Be aware that canceling lessons for reasons other than illness or family emergency may affect your grade.

## **Requirements:**

- preparedness for and attendance of each lesson (regular practice outside of lesson required, ideally at least 2 hours a day for majors and 1 hour a day for minors) For students who have trouble managing their practice time, weekly practice reports may be required by the professor as part of the lesson grade
- attendance of flute studio class, convocations, guest masterclasses, and Woodwind Area recitals during  $6^{th}$  period
- 3. attendance of **all flute recitals** students, faculty, and guest artists. If you must miss a flute-related event, contact Dr. Stoner as soon as possible to determine if your absence will be excused.
- 4. each student in flute studio must play a jury at the end of each semester, unless they have given a solo recital during the semester
- 5. students will write constructive comments for performers in flute studio class
- 6. All majors in studio will perform on at least one Woodwind Area recital or Convocation.
- 7. students will listen to available recordings of works they are studying this will be included in lesson preparation grade
- 8. THEME DAYS are meant to be fun but also require some preparation to be respectful to your peers and professor, preparation is included in your studio class grade
- 9. Behave professionally and respectfully in the School of Music (classes, rehearsals, and performances) as an ambassador of the UF Flute Studio.
- 10. Cell phones must be turned off during all events, including lessons and studio class.
- 11. Maintain notes detailing practice sessions (time/day/goals/accomplishments), listening log, and lesson comments.

# **Special Project this Semester:**

## SAMPLING/ELECTRONIC FLUTE COMPOSITION:

Students will compose a short (1-3 minute) work that utilizes electronics or sampling in some way. The sampled sound could be from a pre-existing flute piece or newly written for this purpose. The final product could be a recording or a work for solo flute with electronic accompaniment. All new works will be presented/performed in our studio class on Monday, April 22, 12:50 PM. \*this fantastic idea and all theme days this semester were created by Ellie Wolpert <3
