### Course Goals and Objectives

By the end of this course, students will be able to:

- Demonstrate professional-level arts and culture practice in healthcare, public health, or community health settings through direct experience in a practicum site.
- Develop and apply practical skills for using arts and culture to address public health priorities or enhance well-being in community or clinical environments.
- Critically reflect on project planning, implementation, evaluation, ethics, and practice.
- Understand and engage with organizational structures that support arts in health and arts in public health work, including interprofessional collaboration.
- Strengthen communication and partnership-building skills, especially across disciplines like health care, public health, and creative sectors.
- Articulate the social responsibilities of arts in health and arts in public health practice, with a focus on equity, inclusion, and cultural responsiveness.
- Document and assess the impact and outcomes of creative strategies used in their practicum, through written reflections, evaluation tools, and final reporting.

### Requirement

Students must complete a total of 96 Practicum Hours: 72 Contact + 24 Administrative. In cases of extenuating circumstances, up to 24 hours of alternate activities may be counted toward contact hours with prior instructor approval. Five points will be deducted from the practicum assignment grade for each missing Contact Hour. Three points will be deducted for each missing Administrative Hour.
