**Course Description:** In Applied Studio Voice, the student learns the fundamentals of vocal release and the application of this tone to words and melody. The student is assigned repertoire to learn and master and given vocalizes and other tools for regular vocal practice. Voice lessons are taught 1:1 and students hire a pianist both for weekly rehearsal and 30 minutes per week of their lesson time. Students are required to sing a jury performance for the entire voice faculty at the conclusion of the semester.

**Objectives and Learning Outcomes:** The primary objective of applied studio voice is the emancipation of each student's unique vocal instrument and the application of that freedom to musical expression. Secondary objectives include the strengthening of musicianship, the development of a daily practice routine, the exploration of repertoire, the improvement of foreign language diction, and the development performance practice techniques.

**Music & Materials:** You will be assigned music for lessons. Please acquire this music immediately after assigned. If you have questions as to how to locate, we will discuss – please know, however, that this is your responsibility. Keep your music and related materials organized in a three-ring binder or on a tablet. Please bring all music to your lessons. Also send a PDF of all your music for my tablet for use in your lessons.

You will be graded each lesson for the preparation of the following materials:

- **Poetic recitation.** You are expected to recite the text of each piece before you sing it. Please know the meaning of words and phrases and recite using the poetic form.
- **Individualized musicianship instruction:** depending on your level of musicianship, I may assign a rhythm or self-prepared study assignment each week. If so, you will perform these for me at the beginning of the lesson as part of your lesson grade.
- **Repertoire:** You are expected to accurately learn all repertoire assigned. In addition, you will be responsible for knowledge of the composers and compositional periods, information about the specific compositions, word for word and paraphrased translations, IPA transcriptions, and performance practice research for each piece.
- **Preparation and Practice:** It's always obvious when students make their voice practice a regular routine.

**Collaborative Pianist** – Please hire and show your collaborative partner the highest level of professionalism and respect by providing double sided copies of the music, three-hole punched with translations written in. Please provide the same for any meetings with coach accompanists. Rehearsal

times are the voice student's responsibility and will be set up as soon as the collaborator is determined.

**Recording** – I will expect you use a device of your choosing to record every lesson and listen back to it at least once before your next lesson. Please archive these lesson recordings and so you can refer back to them when the semester is not in session. They will also provide a valuable reference resource for the six days a week you don't have a lesson!

**Reflections** – You will submit two written reflections. One at the beginning of the semester that outlines semester and yearly goals, and one at the end of the semester before juries that reflects on the semester's progress both in performances and practice.

**Evaluation** – Your lesson performance is based upon the following: 14 lessons in the semester and each lesson is worth 100 points. The grade for each lesson is provided at the conclusion of the lesson. Additionally, on mid-term week, I will ask you to sing through all of your semester repertoire for a mid-term grade – this is worth 200 points. You must be singing all of your music correctly (words, notes & rhythms) by that point in the semester. Please note, attendance and preparation for lessons is a critical. Talent will not produce a passing grade, but professionalism will. You will also be responsible for two short reflection essays that speak into your goals and accomplishments. The rest of your lesson grade is divided between attendance (studio class and voice area concerts) and your jury. See the chart below:
