The center was established in 1996, following the development of the nation's first university-level coursework in the arts in healthcare by the center's co-directors at UF in 1995. Master of Arts (MA) in Arts in Medicine The 35-credit online Master of Arts with a major in Arts in Medicine is designed to prepare pre-professionals and professionals in the fields of the arts and health for careers that use the arts to enhance individual and community health, and to effectively develop and manage arts programs in healthcare or community settings. The program provides a solid theoretical foundation, in-depth practical experience, and professional skillsets that will prepare artists to safely and effectively navigate healthcare settings and enhance clinical or public health practices.

Prerequisites and Requirements: Admission to the MA in Arts in Medicine program program requires a bachelor's degree in an arts, health, or related field of study, and completion of the Introduction to the Arts in Healthcare course at UF, or completion of an Arts in Healthcare Summer Intensive, or a minimum of one year of professional experience as an artist or administrator in the field of Arts in Medicine. Requirements of the degree include completion of 35 credits of the following coursework with a 3.0 or higher GPA.
