### MUH6672, section 13C4, Baroque Seminar – Spring 2015

Course Description: This course is an overview of Baroque music with focus on selected topics. We will explore genres and their development, conventions, style trends and techniques of the era, theoretical and aesthetic principles, cultural and historical contexts, production practices, and performance practice issues. Students will listen to assigned musical works outside of class with scores and discuss them in class along with related topics, issues, and other relevant literature. Coursework includes discussion, class reports (written and oral components), short assignments, exams, and a research paper on a topic related to Baroque music.

<u>Prerequisites:</u> MUH536 (Music History-Graduate Review Course) or passing grade on music history diagnostic/placement exam.

Class meetings will consist of a combination of discussion, oral and written reports, score study, and presentation of material. The paper will be written in stages. Comments on paper drafts must be incorporated to the next

draft. Late submissions of any portion of the project will receive a reduction in grade to be assigned at instructor's discretion. Any changes to the syllabus will be announced in class and timely notice will be given. Papers will be submitted to the instructor in hard copy and through Turnitin.com (through E-Learning) as well.

**ATTENDANCE POLICY**: Attendance will be taken at each class session. Students are expected to be on time, present, prepared, and actively engaged for every session for the entire period. Excessive absences, tardiness, and lack of preparation will be noted and will affect the final grade. Specific criteria for make-up assignments to be distributed in class.
