Catalog Description

Helps meet state certification requirements for elementary classroom teachers. Function of elementary school music in aiding the developmental growth of children. *Prereq: HUM 2511 strongly recommended.*

Course Description

The purpose of this course is provide pre-service elementary classroom teachers with opportunities to strengthen foundational music skills and an understanding of how to structure basic music instruction in the elementary classroom, as well as how to integrate musical concepts into all areas of the general elementary curriculum. Students are expected to participate fully in classroom and independent experiences to improve musical and pedagogical skills.

Course Objectives

Upon successful completion of this course, students should be able to:

- create sequential lesson plans for the general elementary curriculum that integrate music skills at an appropriate developmental level for the specified grade.
- design curriculum and assessment based on the Florida music standards for elementary grades.
- teach integrated music content through singing, playing instruments, listening, creating, and/or moving.
- sing and perform on instruments from basic notation with correct pitch, rhythm, and technique appropriate for the elementary classroom.
